Due to the limited number of presentation slots and to best serve our attendees, submissions rated highest by the Advisory Board will be invited to the event.

If accepted for a presentation slot, the 15-minute presentation would typically include:

- 1. The ingredient's distinguishing technical properties, benefit(s) and application(s).
- 2. Regulatory considerations including GRAS status.
- 3. Its brand name and how the ingredient would appear on labels.
- 4. Companies can submit up to two TSS submission forms. Submitting a Technology Snapshot is Free. However, if a submission is accepted, a Technology Snapshot Speaker registration fee of \$795.00 is required to help cover out-of-pocket costs. Only one such reduced fee is given per accepted submission. An accepted presenter has access to all presentations, meals, networking events, exhibits and materials made available to the general attendees.
